## Explorers' Edge Annual General Meeting Minutes Friday, October 18, 2024 Zoom

Call to Order and Chair Remarks: Hilary Chambers called the meeting to order at 9:35am.

Approval of Agenda – October 18, 2024 Motion: Michael Martyn Seconded: Darren Smith Discussion: n/a Carried.

Approval of 2023 AGM Minutes – September 20, 2023 Motion: Angela Pollak Seconded: Dave Anderson Discussion: n/a Carried.

CEO Murphy noted this is the first year hosting the AMG as a closed membership; this presentation is not just a formality, but an opportunity to acknowledge everyone on the call and highlight the work undertaken over the last fiscal year. Murphy then began the meeting with a land acknowledgment. Mentioned last year's AGM location at the Muskoka Discovery Centre and noted their new Misko-Aki: Confluence of Cultures exhibit (that was highlighted as part of last year's AGM) being honored with a nomination for a TIAO award at their summit next week.

Discussed the upcoming tourism summit – reminded board members to sign up to attend or let us know about overnights if required as soon as possible.

Murphy updated the board with a brief overview of the fiscal 2023-2024 year noting the organization's mission and vision along with the Ministerial pillars that govern the transfer payment agreement.

Murphy discussed the current staff and changes to the staff during the fiscal year. Murphy noted additional administration items that included updates to our Privacy Policy, Articles of Incorporation, and TICO. Murphy then provided an overview of fiscal work completed with the Ministry i.e. Business and Operational Plan, reports such as the Attestation Report & Budget report(s), onboarding of ministers and ministerial staff in addition to the organization of virtual meetings with the RTO's.

The fiscal year, as noted by Murphy also included industry communication such as town halls and a regional tourism summit and the launch of the women in tourism co-creation lab. The staff was kept busy with regional and provincial outreach, as noted by Murphy by the list(s) of public engagement sessions.

Work completed updating governance to comply with the Ontario Not-for-Profit Corporations Act ("ONCA") was noted and directors were briefed on the project management software Wrike.

Murphy continued with updates related to the pillars that included product development, investment attraction, workforce development, marketing and partnership. Murphy noted that the AGM presentation can be found online for further review.

Murphy opened the floor to questions – none. Chambers shared how proud she was of the team and how much can be accomplished with a limited budget. Also noted the rebound from COVID and how successful she felt that has been. Monk mentioned last year as a transitional year, creating exponential growth for the years to come - business strategy, travel agency and workforce development. Provincial framework is not long term strategic; congratulates James on taking the reins of the organization and keeping the organization moving forward.

Murphy moved to the financial review portion of the meeting noting the year end financials were circulated March 31, 2024, the draft audited financials circulated October 9, 2024 along with the financial notes document.

Murphy noted that the financials were prepared by Gingrich Harris Copeland, Chartered Professional Accountants and noted that:

- Income Statement or Statement of Operations best reflects our activities
- Major source of income, transfer payment from Ministry of Tourism, Culture and Sport
- Other income includes Partnership & FedNor

Murphy asked for any questions from the board on the financials, which were circulated to the board before the meeting and can always be found on the Explorers' Edge website under 'About us' – 'Board minutes & agendas', no questions were posed.
